Whether out of fear, shame or despair – if you have experienced sexualized violence, you may not be ready to contact the police immediately after such an occurrence. But regardless of whether you want to press charges or not, you need immediate medical care – even if you don't initially notice any visible injuries.

Time plays a decisive role in securing evidence. The most evidence can only be secured **in the first 72 hours** after the occurrence. Please seek medical care **as quickly as possible**. Please contact one of the 'partner clinics' central emergency departments.

**The sooner, the better** – particularly if you suspect that a knockout substance was used, since these can only be detected for a few hours depending on the substance. The examination also assesses the risk of communicable diseases and a possible pregnancy.

## You have several open paths

### 1. Immediately file a report with the police

Despite possible concerns, we would like to absolutely encourage you to report this to the police. Only then is prosecution possible. If you want to file a report immediately, contact the police (Tel. 110). They will immediately initiate an investigation and all necessary steps.

### 2. Immediate medical care and confidential securing of evidence

If you are unsure whether you want to file a police report immediately after the occurrence, you can seek help independent of the police. Please contact one of the partner clinics listed as quickly as possible. In addition to the medical examination, the evidence of the crime can also be confidentially secured there on request. The trace evidence is encrypted and securely stored for 10 years. If you later decide to press charges, the police can access the evidence with your consent. The confidential secured trace evidence can be handed over to the police on your behalf, destroyed prematurely at your request or, without your involvement, after the retention period has expired.

You can choose to contact the **Opferhilfe Land Brandenburg e.V.** counselling centres that will provide you with strictly confidential, optionally anonymous, free counselling in all languages (via translator).

The documentation of injuries and the securing of evidence with subsequent preservation are free of charge for those affected.

### 3. Immediate medical care without the securing of evidence

Even if you do not wish to secure evidence, you should have a medical examination as quickly as possible. You may also receive information on counselling services on request.

## Important information on securing evidence

Please do not wash yourself before the securing of evidence, even if you find this difficult to do. Important evidence could be lost as a result.

The service focuses on **persons affected by sexualized violence**, regardless of gender, origin, religious denomination, sexual identity or social relationship to the perpetrator.

The examination is **confidential**, but not anonymous. The affected person's insurance data is recorded at the hospital. This is important for identification in the event of a later report. However, until then, medical confidentiality applies and the information is encrypted against third parties by the hospital.

Bring worn items of clothing or other evidence carriers, such as a comforter cover, with you to the clinic. Moist evidence carriers should preferably be stored in paper bags in which they can dry.

For initial treatment, a physical examination is carried out followed by written and photographic documentation of the evidence. Injuries requiring treatment are treated and further diagnostics are initiated on a case-by-case basis. You can be accompanied by someone you trust for (emotional) support.

The trace evidence is secured for use in court. It is your decision whether to report the crime.
